





#### **PAULDING THEATRE REMEMBERED: A GLIMPSE FROM THE '70-'85 ERA**

Larry Tope was a 17 year old living the teenage life in the rural village of Paulding in 1970. His parents, Lowell and Margaret Tope, owned a local hardware store Down-town Paulding spending their days assisting village residents with all their hard- ware needs. They would look out their front windows of the store and admire the old Grand Theatre and reminisce about days gone by. The Tope's, together with Bill Straley and Gary Wobler, decided to resurrect the whimsy of the old theatre for the village of Paulding.

The summer of 1970 Larry remembers spending days with Ken McMichael and David Straley (among others) taking apart the seat- ing to get them re-upholstered to their former glory (there were over 500 seats in the Theatre!). They re- painted, put on a new roof and purchased a new screen for the projectors. The first movie shown in the new Paulding Theatre was Disney's "Apple Dumpling Gang". Larry remembers the line to get in and see this film

was all the way down the sidewalk to the main intersection of Paulding!

A Mr. Haney ran the projectors, he was the original projectionist when the theater opened in the 40s. He ran the 2 projectors seamlessly, he was the expert. Later on, Paul Ludwig took over this position at the theatre. The theatre was state of the art with two projectors, they used a broker in Cleve- land to get the latest flick. Depending on the film, royalties would be anywhere from 50-70-90 cents per ticket, and Larry remembers that a ticket in those days was only 50 cents! So, it makes sense that concession prices had to balance any losses from the royalties of the film.

Larry remembers there was a spiral staircase that led up to a second story office that had a small screen and speaker to watch while doing other office work. Lowell also was the master of the boiler as that was a previous profession of his, especially his time spent serving in the US Mili-

Concessions were run by the local young people of the area - Dorothy Dix, Sue Vance, the Kauser twins (just to name a few) — along with Larry when he was available in between school obligations. Cleaning up the fallen popcandy boxes after the picture was John Miller. Paulding Theatre was

managed and operated by the Topes from early 1970 through about 1984. Sometime in there, Mr. Wobler and Mr. Straley were ready to move on, so the Tope's bought out their share of the business so they could do just that. As the 80s dawned on the Tope family, Lowell and Margaret were empty nesters and decided to start downsizing in life. They sold the theatre to Larry Gorrell at that time, and he used it for a number of years as an auction house. Some years later, Gorrell then sold it to the Vogels who owned the local bar down the street. They had hopes of turning the Paulding Theatre into a night club. And there she sat, and sat... waiting for the dreams of grandeur of the good old days to be revived again. Tales of people showing up to purchase some popcorn or other concession goodies even though they weren't planning to watch the latest showing along with other stories about walking the gangway on the second story to reach light bulbs when they needed changed (that was Lowell's job) will now be archived in the memories of all closely associated with Paulding Theatre.

Overseas, I do a lot of our grocery shopping as many stores do not have parking lots. It is easiest for me to pick up some groceries when I am out on my motor scooter as I can park on sidewalks. When shopping overseas right after getting back from being home in Indiana, I realized I had forgotten shopping bags, and it is expected that you bring your own reusable bags to stores. No problem, I had my motorcycle helmet bag with me, which is like a large drawstring bag made of fleece. I could put some food in the back case of my motor scooter and carry the rest in my helmet bag.

I was buying food for a family that was coming over that evening. I filled my back case with items and the rest of the groceries fit in my helmet bag. Off I went home. About midway home, I realized orangish-yellow liquid sloshing on the foot platform of my motor scooter - a juice container was leaking. ## **ROANOKE ELEMENTARY DONATE 683 PAIRS** OF SHOES TO CHANGING FOOTPRINTS



School recently collected 683 pairs of new and gently used shoes for Changing Footprints. Led by 5th grade teacher Jamilyn PeGan the 441 students reacted enthusiastically at a presentation given in the gymnasium by Cheryl Brockmann of Changing Footprints. Over a twoweek period, almost every student contributed to the ever-growing pile of shoes. It was exciting to see the bags pile up more and more every day. Roanoke Elementary has held shoe drives in previous years as well. All of these donated shoes

will be paired and sorted into over 40 categories at the Changing Footprints warehouse in New Haven. The shoes will be placed into banana boxes and labeled. Social service agencies contact Changing Footprints, requesting specific types of shoes, such as "3 boxes of men's sizes 9-12, athletic". Changing Footprints often delivers 15-20 boxes at a time to meet the various agencies' requests. No one is ever charged for the shoes. Recipients include the poor and homeless, shelters, churches and school systems. Well over 90% of all donations stay in Northern Indiana.


Changing Footprints is a

organization, without any paid staff. There are 5 main distribution locations in Indiana: Rushville, North Indy, South Indy, Greenfield, and Northern Indiana. Established in 2005, they have distributed over 600,000 pairs in the past 18 years. Locally, the Northern Indiana/Fort Wayne branch collected over 35,000 pairs in 2023. The new and used shoes come from a variety of sources: collection bins at athletic facilities, local libraries, physical therapy offices, shoe stores and churches. Shoe drives by schools, churches, and businesses are essential in the effort to meet the growing demand for gently used shoes.

Changing Footprints accepts all styles, types and sizes of shoes, no matter their condition, or even if they are a single shoe without a mate. Damaged athletic style shoes are ground up into playground surfaces and running tracks by Nike, Zappos and other companies. #### **MILITARY HISTORY IN PAULDING COUNTY**



Orval Cletus Lehman was born December 6, 1894 in Payne, Ohio. The son of William Elmer, born 1870 in Ohio and Elnora Ella (White) Lehman, born 1876 in Ohio. This couple was married April 20, 1893 in Paulding, Ohio. By 1900, this Lehman couple had three children. Orval C. born 1894, Clara J. October of 1896 and Merit Ray born February 7, 1899. As a side note, Clara went on to become teacher in the public school system for 44 years, alright back on track! The family was living in Benton Township. William was a farmer. His brother, Samuel H. Lehman also lived with this family.

By 1910, the Lehman family grew by four more children. Leona M. Born 1901, William Hobart 1903, Emil John April 21, 1905 and Mildred Elnora February 25, 1908. This family was living in Paulding on Harrison Street. William was a teacher at Paulding Schools. Orval was in school as well as most of his brothers and sisters.

On June 5, 1917, Orval went to the Paulding precinct and registered for the draft. He was working as an assistant cashier at the Payne State Bank. He was single, medium height, slender build, brown eyes and dark hair. Orval's brother, Merit, registered September 12, 1918. Medium height slender build, blue eyes, dark hair, single and still in school. He was not selected

On May 25, 1918, Orval joined the National Army out of Paulding. He served in the 159th Depot Brigade until June 16, 1918. He then transferred to Battery D. 142ª Field Artillery until July 16, 1918,

then transferred to Quartermaster Corp. He was promoted to Sergeant October 30, 1918. He was honorably discharged December 26,

Orval met a gal named Cecilia Anita Radenbaugh, and on June 25, 1919 they married in Paulding. She was the daughter of Francis P. and Cyrentha Geneva Radenbaugh from Harrison Township. In 1920, Orval and Cecilia were living in Payne on North Main Street.

Orval was working as a cashier at the State Bank. On November 3, 1921, Orval was surprised with the birth of a brother. Harry Allen Lehman. On December 19, 1921, Orval and Cecilia were blessed with the birth of a daughter, Marjorie C. By 1930, the Lehman's were still living in Payne on North Main Street and Orval was still a cashier at the bank. On May 9, 1934, a son, Edwin C. was born.

By 1940, still living in Payne, Orval was working as an insurance agent. Daughter Marjorie was a senior at the Payne school. In 1942, Orval registered for the World War Two draft. At his age of 48, he was not selected, but his brother, Harry, who registered February 16, 1942, was selected. He was a Corporal in the Marine Corp. serving with Company E. 2nd Battalion, 6th Marines. Harry was wounded at the Marianas Is-

In 1944, Orval's mother, Elnora, passed away. She was buried in Lehman Cemetery. A year later, in 1945, Orval's father, William, passed away was buried beside Elnora.

By 1950, Orval, Cecilia and son Edwin, were living in Payne. Orval was a sales manager for a real estate company. On October 9, 1952, Orval passed away at the Lutheran Hospital in Ft. Wayne. He passed away due to heart disease. He was buried in Lehman Cemetery. In 1988, Cecilia joined him.

The effort to assure that educational needs and requirements are met for all the children in our school district is a challenge, especially when you consider that several of our school age children are receiving their education outside of the traditional school setting of our school building. On any given school day, Antwerp Local School provides an educational setting for 703 students in grades PK-12. Twenty-one high school students are enrolled in at least one College Credit Plus (CCP) course that may involve traveling to a college campus or completing the course online. Thirty-six students in grades 11 and 12 attend Vantage Vocational School in Van Wert. Nine students attend the Western Buckeye Educational Service Center Opportunity School located in Paulding, Ohio. We have two students who are transported and attend the Bryan Autism Center. There is also one student currently at home receiving their education through our NOVA online program. While technically not Antwerp students, we have 29 school age children receiving their education in a "home school" environment.

We are excited to let you know that construction of the "Range" Wellness and Recreation Center (located to the west of the baseball and softball complex) is nearing completion. A significant portion of the project was funded through ARP ESSR federal funds. The Center includes a recreation area, multi-purpose classroom, restrooms, concession and patio area, press box, and storage areas. Specifically, the Center will provide additional space for early childhood programs, a home base for our wrestling program, and space for community members to utilize for meetings or exercise. An official Open House date will take place sometime this spring. Stay tuned for more information.

## **BOARD OF EDUCATION**

## **HOW CAN WOMEN BRIDGE THE RETIREMENT GAP?**

March 8 is International Women's Day, a day for celebrating all the accomplishments of women around the globe. But many women still need to make up ground in one key area: retirement secu-

Women's challenges in achieving a secure retirement are due to several factors, including these:

- Pay gap It's smaller than it once was, but a wage gap still exists between men and women. In fact, women earn, on average, about 82 cents for every dollar that men earn, according to the Census Bureau. And even though this gap narrows considerably at higher educational levels, it's still a source of concern. Women who earn less than men will likely contribute less to 401(k) plans and will ultimately see smaller Social Security checks.
- Longer lives At age 65, women live, on average, about 20 more years, compared to almost 17 for men, according to the Social Security Administration. Those extra years mean extra expenses.
- · Caregiving responsibilities - Traditionally, women have done much of the caregiving for young children and older parents. And while this caregiving is done with love, it also comes with financial sac-

rifice. Consider this: The avemployment-related costs for mothers providing unpaid care is nearly \$300,000 over a lifetime, according to the U.S. Department of Labor — which translates to a reduction of 15% of lifetime earnings. Furthermore, time away from the workforce results in fewer contributions to 401(k) and other employer-sponsored retirement plans. Ultimately, these issues

can leave women with a retirement security deficit. Here are some moves that can help close this gap: • Contribute as much as

possible to retirement plans. Try to contribute as much as you can afford to your 401(k) or similar employer-sponsored retirement plan. Your earnings can grow tax deferred and your contributions can lower your taxable income. (With a Roth 401(k), contributions aren't deductible, but earnings and withdrawals are tax free, provided you meet certain conditions.) At a minimum, contribute enough to earn your employer's matching contribution, if one is offered, and try to boost your contributions whenever your salary goes up. If you don't have access to a 401(k), but you have earned income, you can contribute to an IRA. Even if you don't have earned income, but you have a spouse who does, you might be eligible to contribute to a spousal IRA.

• Maximize Social Security

benefits. You can start taking Social Security at 62, but your monthly checks will be much bigger if you can afford to wait until your full retirement age, which will be around 661/2. If you are married, you may want to coordinate your benefits with those of your spouse - in some cases, it makes sense for the spouse with the lower benefits to claim first, based on their earnings record, and apply for spousal benefits later, when the spouse with higher benefits begins to collect. Build an emergency

fund. Try to build an emergency fund containing up to six months' worth of living expenses, with the money kept in a liquid account. Having this fund available will help protect you from having to dip into your retirement accounts for large, unexpected costs, such as a major home or car repair.



## KLOPFENSTEIN, ROGERS INTRODUCE BILL TO MODIFY COUNTY ENGINEER VACANCIES



State Representatives Roy Klopfenstein (R-Haviland) and Elgin Rogers (D-Toledo) today introduced legislation to modify procedures for filling county engineer vacancies.

The legislation seeks to aid counties in finding more qualified individuals to run for county engineer and establish new opportunities for counties that are unable to fill an engineer vacancy.

The proposed legislation will:

• Grant county commissioners the authority to contract with engineers from other counties to fill vacant positions in the county engineer's office for the remainder of the term if they haven't been able to fill the vacancy through either election or appointment.

• Eliminate the pay discrepancy for engineers who also maintain a private practice.

"This legislation mirrors similar provisions that exist for county coroners, which has proven to be invaluable when a county is unable to find someone to fill a vacant office," said Klopfenstein. "The key distinction in this legislation is the stipulation that the county with the vacancy must compensate the contracted engineer at the same rate as they would their own engineer."

"Our bipartisan legislation will give communities across the state the resources they need to fill county engineer vacancies," said Rogers. "I am proud to work alongside our county governments to find effective solutions."

The measure awaits a bill number and committee assignment.
