

PC LAND BANK **SUBMITS 2024 BLIGHT APPLICATION**

The Paulding County application for the Ohio Department of Development (ODOD) residential and commercial blight program was completed and submitted on March 8. Estee Miller, Maumee Valley Planning Organization, shared with the Land Reutilization Committee (Land Bank) that the application for the residential and commercial blight program included 43 properties from throughout the county. Miller shared that the estimated application price tag for remediation is \$1,115,316. The county was allocated \$500,000 in the program. Because the county exthe ceeded allocated amount, there will need to be \$154,500 of match money provided by the Land Bank committee if the total application is accepted. Purchased properties can also be considered match.

The committee was then updated on the progress of the former Paulding theatre lot by Tim Copsey, Paulding County Economic Development Director. This project is one of several in the ODOD county using Brownfield program funds. The theatre and adjacent building demolition has completed and all debris removed. The replacement sidewalks along West Perry Street were framed, with cement recently poured. The group will next be made aware of the cost of putting metal siding on the now exposed, east wall of the Hawg's Tavern building.

The county continues to have ongoing remediation work taking place at the former Grizzley Brake property. The current owners, Arvin Environmental Management, LLC have invested in having natural overgrowth and foliage removed about 40 feet inside the fence perimeter. This has provided a much better view of the chain link fence enclosing the property, and revealed some needed repair. Quotes are taking place on that now. A bid application is also being prepared to drain ponds and level the dirt mounds, at both this site, and the former Stokely site across the road.

Final committee discussions were in regard to following up on properties still owned by the committee and understanding the upcoming mowing maintenance that will soon be required on the properties. Thoughts were then shared in how to proceed in future marketing of remediated properties for development.

MILITARY HISTORY IN PAULDING COUNTY



For Major Annie Guyton Fox I have to break Paulding County Veteran prodigal. But, I found this individual who served at Pearl Harbor who I felt needed to be covered.

Annie was born August 4, 1893 in Pub Nico, Yarmouth County, Nova Scotia, Canada. The daughter of Dr. Charles James and Deidamia Ann (Guyton) Fox. Annie had three sisters and three brothers. Leslie born in 1886, Maria Guyton 1887, Charles James Jr. 1888, Dorothy E. 1889, Lyle Cleveland 1891 and Eunice 1898. In January of 1914, Annie entered the United States at the border crossing. She was listed as a student.

Annie's brother, Charles will serve in World War One as a Lieutenant in the Navy. Her sister, Dorothy served overseas in World War One in France as a nurse. Serving with Casual Nurse Detachment. She returned to America May 27, 1919 on the ship, S.S. P.F. Wilhelm. Landing at Hoboken, New Jersey. Annie served in World War One. Enlisting in the Army Nurse Corp July 3, 1918. Serving months before the war ended.

Showing her abilities to care for the wounded. After the war, she found her way to New York where she became a practicing nurse. On November 26, 1919 she filed at the New York County Supreme Court to become an American Citizen. She was listed as light complexion, dark hair and blue eyes. Her service in the Nurse Corp will end October 3, 1924. She re-enlisted October 30, 1925. Numerous places she went to train and work as a nurse. Stationed at Fort Sam Houston April 20, 1939. While there, on April 1, 1940, she was promoted 2nd

Annie was stationed at Pearl Harbor at the Station's Hospital in November of 1941. She was promoted to 1st Lieutenant. She was the head nurse at Hickam Field. A 30 bed hospital with six nurses. She was well liked and respected.

On December 7, 1941, Pearl Harbor came under attack. The 47 year old quickly took control of the situation as bombs rained down on the air base. First hand accounts of the attack stated that the planes were flying so low that the nurses could see the Japanese pilots talking to each other. Casualties poured into the hospital within minutes of the first bombing run. Bombs fell around the hospital. One bomb left a 30 foot crater only 20 feet away from the hospital wing. The casualties were so numerous, that nurses barely had time to administer pain medication before triaging them onto Trippler Hospital. Lt. Fox rallied nurses, N.C.O. and officer's wife's to organize in the making and administering hundreds of wound dressings. Lt. Fox was herself, participating in surgery, administering anesthesia during the bombardment. Eighty two Army nurse were stationed in Hawaii.

Serving at three different Army Medical locations. On October 26, 1942, Lt. Fox was recognized for her bravery. She became the first woman to be awarded the Purple Heart medal. On October 6, 1944, she was awarded the Bronze Star. The Purple Heart was returned. Also in 1944, Annie was promoted to Captain. By 1945, Annie was promoted to Major. She retired from service to her Country, December 31, 1945.

She moved to California, living out her days until she passed away, January 20, 1987 in San Mateo, California. She is buried in San Francisco National Cemetery, San Francisco, California, Section A. Site 657-A. On March 8, 2017, Hawaii Magazine ranked Major Annie Guyton Fox, among a list of 15 most influential

So, you may want to keep these reductions in mind when deciding when to begin accepting benefits. Once you reach your full retirement age, you can earn any amount without losing benefits. (Also, at your full retirement age, Social Security will recalculate your benefit amount to credit you for the months you received reduced benefits because of your excess earnings.) • Spouse - Spouses can receive two types of Social Security benefits: spousal and survivor. With a spousal benefit, your spouse can receive up to 50% of your full retirement benefits, regard-

less of when you start taking them. (Your spouse's benefit can be reduced by the amount of their own retirement benefit and whether they took Social Security before their full retirement age.) But with a survivor benefit, your decision about when to take Social Security can make a big difference. A surviving spouse can receive the larger of their own benefit or 100% of a deceased spouse's benefit, so if you take benefits early and receive a permanent reduction, your spouse's survivor benefit may also be reduced for

their lifetime. When to take Social Security is an important — and irrevocable — decision. So, consider all the factors before making your choice.

COLIN WHITE ADDED TO OHIO BASKETBALL'S HISTORICAL LIST

Colin White knows something about the history of the Mr. Basketball award.

Now the 6-foot, 6-inch Ottawa-Glandorf standout is part of that history after being voted Ohio's 2024 Mr. Basketball by the Ohio Prep Sportswriters Association.

Quizzed about his knowledge of former Mr. Basketball winners not named LeBron James, White responded without hesitation, "Malaki Branham, Gabe Cupps, Devin Royal, Jamar Butler and Greg Simpson."

White has averaged 24.9 points, 8.2 rebounds, 3.1 assists and 2.6 steals a game this season for O-G (24-3) heading into its Division III state semifinal against Canal Winchester Harvest Prep on Friday at the University of Day-

ton Arena.
With 1,995 career points, he is five points away from becoming the first Ottawa-Glandorf player and first Putnam County player to score 2,000

He is already a two-time first-team Division III All-Ohio selection and will receive that honor a third time when this year's All-Ohio teams are announced next week.

Ottawa-Glandorf has reached the boys state basket-ball tournament all four years of White's career. The Titans were state runner-up last season and in 2022 and have a 94-15 record in the last four

Next season White will wear an Ohio State uniform after signing with the Buckeyes in November. He chose OSU over Butler, Northwestern, Cincinnati and TCU and recently reaffirmed his commitment to the Buckeyes after Jake Diebler was hired to replace Chris Holtmann.

Michigan State, was the runner-up to White in the Mr. Basketball voting. The other finalists were J'Allen Barrino (Malvern), Alex Bruskotter (Shelby), Marcus Johnson (Garfield Heights), Kruz McClure (Westerville South), Tyler McKinney (Cincinnati Winton Woods), Hayden Nigro (Louisville) and Mason Shrout (Preble Shawnee).

He said his feeling at the moment he learned he would be joining the list of Mr. Basketball winners was "kind of a sense of accomplishment."

"It's something you heard about growing up," White said. "You want to win. It's something you dream about winning and to actually hear I won is really cool. It's a great feeling. It's one of the best feelings of the high school experience."

White is the first Mr. Basketball from northwest Ohio since Lima Senior's Xavier Simpson in 2016. This is the 14th time an Ohio State recruit has won this award in the 37 years it has been given

Improving his shooting in his last two seasons of high school basketball played a big part in getting his Ohio State offer, White said.

His plans this summer start with "just continuing to work on my body."

"I feel like I have a pretty good frame, but I still need to fill out in certain areas," he

Ottawa-Glandorf coach Tyson McGlaughlin said, "I've got chills running down my body just thinking about it.

"A lot of times I feel like we get overlooked here in northwest Ohio, especially in our area. To see one of our own recognized at the highest level, it's just a feeling I've never been a part of it. There are a lot of really good players. To me, he separated himself by performing his best on the highest stages."



STATE PATROL INVESTIGATES FATAL TRAFFIC CRASH

2024 SOLAR ECLIPSE



The first solar eclipse visible in our area in a long time will take place on Monday, April 8th, 2024, beginning at 1:53 p.m. The next solar eclipse will be in 2044 but it will be visible in South Dakota. You'll have to travel for that one. Better get a pair of glasses pronto.

A solar eclipse happens in the same place once every 350 years.

People have been booking motels and coming from great distances to see this event, which you will be able to see for free. Grabill Hardware has a magazine showing the path that it travels. It is traveling Northeast and it looks like Harlan is just on the edge. It's hard to tell exactly on the map because it has no cities, only counties.



It appears to me that the closest way to get to the very center, would be to take US 24 to Antwerp. Just look out for the traffic in Antwerp

According to Mrs Google the eclipse begins at 1:53 p.m. and ends at 4:24 p.m. which is well over 2 hours. Would you believe I'm having a difficult time subtracting those numbers. I think it's 2 hours and 71 minutes whatever that is.

I have heard that it gets nearly dark in daytime, I really don't know. I wonder what our ancestors would have thought, when it's suddenly totally dark. I think it becomes twilight. Especially the farmers if their chickens went to roost. They probably wouldn't have known ahead of time. On February 29th, 1979, there was a total party atmosphere. People had driven for hundreds of miles to see the unique event. Pack your picnic basket and let's all go to Antwerp. Let's hope it is not a cloudy day and we can see this wonderful event. We'll all be watching the weather forecasts and hoping for a sunny day.

I have since learned that the total eclipse only lasts a couple of minutes max. Perhaps West Bend will give us more info. I have heard there is a plane that will travel from Dallas to Detroit following the eclipse. That one is booked but I guess they opened another. The radio said you can book a motel in Vincennes for only 7,000 bucks. Guess I'll just go to Antwerp.

carawas County. To qualify as a tenant, the hunter must reside on the property, pay rent, and derive more than 50% of their income from agriculture production on that property. The hunter was found guilty of providing false information to game check a deer and paid \$175 in fines and court costs.

State Wildlife Officer Nick Oliver, assigned to Champaign County, recently attended the Whitetails Unlimited banquet at the Champaign County Fairgrounds. Nearly 500 people attended the event, which raised funds for the Champaign County Outdoor Heritage Chapter's youth pheasant hunt. The Whitetails Unlimited mission is to raise funds in support of educational programs, wildlife habitat enhancement and acquisition, and the preservation of hunting traditions and shooting sports for fu-

ture generations. Northwest Wildlife District Two

State Wildlife Officer Michele Butler, assigned to Erie County, and Wildlife Investigator Kevin Good, assigned to Lake Erie, received information that several white-tailed deer bucks were harvested by one hunter

during the weeklong gun hunting season. The officers found that one individual had harvested three bucks during gun season and two other individuals had game checked a buck on behalf of the hunter. The hunter was charged with taking more than one antlered deer, taking additional deer before tagging the first, and failing to game check two deer. The illegal deer parts and the firearm were forfeited to the state. The hunter paid \$275 in fines and court costs as well as \$4,183.73 in restitu-

In February, State Wildlife Office Ryan Burke, assigned to Hancock County, was on patrol at Wildlife Killdeer Plains Area. He was approached by two birders from Wooster who were unfamiliar with the area and seeking guidance. Officer Burke pointed out the portions of Killdeer Plains Wildlife Area open to walk-in access and gave the birders directions to good viewing locations for swans, ducks, and short-eared owls. He also showed them the lo-

cal bald eagle nest. Northeast Wildlife District Three

State Wildlife Officer Evan Huegel, assigned to Ashland County, examined white-tailed deer harvest records and noticed a discrepancy. He determined that a hunter had harvested a deer before purchasing a deer permit. The deer was seized, and the hunter was issued a citation for hunting deer without a valid deer permit. The individual was ordered to pay \$337 in fines and court costs, pay \$250 in restitution, and serve 365 days on probation. The venison was donated to a local food bank.

Southeast Ohio Wildlife District Four

State Wildlife Officer Jeff Berry, assigned to Muskingum County, received a call from an individual who had a snake stuck behind a kitchen cabinet. Officer Berry responded to the call and found an eastern gray

rat snake stuck to glue traps that had been set for mice. Officer Berry safely removed the snake from the glue traps and released it into a nearby wooded area. In March, State Wildlife

Officer Bob Nelson, assigned to Ross County, and State Wildlife Officer Tyler Fields, assigned to Scioto County, responded to a call about two white-tailed deer hanging behind a residence well after the end of the 2023-24 deer hunting season. The officers contacted the homeowners, who stated their son harvested the deer in early December. The officers found no harvest records for the deer. Officer Nelson contacted the suspect and learned the individual had harvested both deer during the deer gun season and failed to complete the game check process. The suspect was issued several summonses, and the case is pending in Gallipolis Municipal Court.

Southwest Ohio Wildlife District Five

On opening day of the 2023 dove hunting season, State Wildlife Officer Gus Kiebel, assigned to Adams County, checked dove huntat Fallsville Wildlife Area. He contacted two subjects who were hunting outside of a blind. Neither individual had a permit to hunt the controlled access field that day or a valid hunting license or HIP survey. Both hunters were charged for hunting without a license and each paid \$275 in fines.

State Wildlife Officer Jasmine Grossnickle, assigned to Miami County, recently attended a career day at Edison Community College. The event was hosted by the Ohio Farm Bureau and attended by more than 150 students. Officer Grossnickle spoke with students who were interested in conservation careers.


